“What Happened to Charlotte?”

A story of patient errors and how they happen.

This is a very brief synopsis of a program I attended at the SGNA conference in Florida last year. Remember this could happen to any of us.

Charlotte was a 61 year old Speech Pathologist and minister who loved skiing. She was a wife, mother and grandmother. She had heartburn and reflux that went to the hospital for a Fundal Plication on 1/10/2000. Pre op she had perfect lungs and liver. After the surgery the physician stated, “I made a mistake”. Post op the

following occurred: She had personality changes and brain damage. She was put on heparin and coumadin with no labs done. When they were finally done, the Hgb. was so low that it couldn't be possible so it was disregarded. The nurse didn't notify MD of the labs. The lab tech drew an insufficient amount of blood. No one acted on her shortness of breath. No one was available to re-draw the blood. No one advocated for a critically ill patient and the patient coded. The patient was transferred to another facility on 1/31/2000. Charlotte spent 2-1/2 months in the new facility on a vent, 3 months in rehab, she was comatose for several months. She had a PEG and PEJ, speech therapy, OT, PT, and respiratory therapy treatments. Her losses included her good health, she had to move, her ministry, lost friends and her job. Her role was reversed. Her dog died and her husband had Alzheimers. She had short term memory loss and she lost her life as she had known it. She had additional medical issues including depression (do you wonder why?), vomiting after meals which led to hernias developing. These hernias were very large and uncomfortable. She even got a ticket for “No seat belt” because she had no physical excuses. On March 28, 2006 she had these repaired. The surgery was a success until 5 hours later. She ended up on dialysis and was intubated. Charlotte died on April 10, 2006. Remember our patients are someone's parents and/or grandparents. All this family wanted was an apology, the communication of events, an acknowledgement, assurance, and all the facts. All the family wanted was appropriate compensation.

The compensation was used for Boys/Girls Club scholarships to 2 colleges. New policies and procedures were established for labs, nursing and physicians including the JACHO's new Patient Safety Goals-Critical Lab Values in 2005 and Safe Delivery of Anticoagulants in 2008. Take this story with you. Patient safety is no accident and you can make a difference. The person presenting this program was Charlotte's daughter, a nurse at Mass. General. If you ever get a chance to hear this lecture, don't miss it, it was eye opening and a tear jerker. Cathy Bolton, RN, CGRN
